POLICE ITEMS: PC Andrews reported: The informational sheets she provided to them contained all the incidents she has handled since the last council meeting; The Infrastructure Grant for the security cameras has been approved.

MAINTENANCE ITEMS: TS Ochsner reported: The department has been conducting locates for Visionary.

LVFD: FC Bangerter reported: Four ambulance calls and one fire call; the siren has been reprogrammed; five new EMT's have passed their tests: Logan Dailey, Alisa Dailey, Todd Erskine, Trish Lowther and Art Lowther. They are nationally registered.

ADMINISTRATIVE ITEMS: C/T Reyes reported: The FY 2024 Town Budget has been submitted to the Goshen County Assessor; The Infrastructure Grant submitted to Goshen Economic Development for security cameras was approved in the amount of \$19,717.00, the cameras are on order with no time line for installation. The property insurance for the Town of Lingle has come up for renewal. Following discussion, the council agreed by consensus to renew the policy with Burns Insurance; The Agreed Upon Procedure's review being conducted by Lenhart Mason, LLC is in the review process and should be issued shortly.

NEW BUSINESS: ATS Dailey addressed the council concerning a Community Garden. Community members are in support of the project and following discussion the council is in support of the project. ATS Dailey will keep the council updated on the progress of the Community Garden.

COUNCIL ITEMS: CM Wilhelm addressed the council on community events and Lingle traffic.
